1. Pledge of Allegiance:

2. Call Meeting to Order:

Meeting was called to order by Commissioner McCullough at 6:31 pm. Commissioners present were Commissioner Tommy McCullough, Commissioner Wayne Skubiata, Commissioner Jodie Benitez, Commissioner Larry Moseley, and Commissioner Amanda Sanchez. 5. Receive monthly report from the Treasurer and consider:

(A). Approval of payment of monthly bills and invoices:

attached) Commissioner Moseley made a motion to accept the budget amendments and Commissioner Sanchez seconded. Motion passed 5-0. EVFD requested a contract invoice change regarding Truck 3 purchase. After discussion a motion was made by Commissioner McCullough to add \$4000.00 to the contract and Commissioner Moseley seconded. Motion passed 5-0.
